RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this “Release”) is made as of November 23, 2015 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent and collateral agent (in such capacity, the “Agent”) for the Lenders (as defined in the Credit Agreement referred to in the Security Agreement (as defined below)), in favor of the Grantor (defined below).

WITNESSETH:

WHEREAS, IPC HEALTHCARE, INC. (formerly IPC THE HOSPITALIST COMPANY, INC.), a Delaware corporation (“Grantor”), and certain other entities executed that certain Security Agreement, dated as of August 4, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Agent, pursuant to which the Grantor granted a security interest to the Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 004599, Frame 0197 on August 5, 2011; and

WHEREAS, pursuant to a payoff letter dated as of November 23, 2015, among the Grantor, the Agent and the other parties thereto, the Agent has agreed to release all its liens on the trademarks and trademark applications of the Grantor identified on Exhibit A attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the Grantor.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, discharges, cancels and releases any and all its liens on and rights in and to the Released Collateral, and reconveys to the Grantor all of the Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.


