## CORRECTION TO ASSIGNMENT OF TRADEMARK AGREEMENT

This Correction to Assignment of Trademark Agreement dated as of November 25, 2015 is intended to clarify the Assignment of Trademark agreement dated November 2, 2005, previously recorded with the US Patent and Trademark Office on November 23, 2005 at Reel/Frame 3199/0112 (the "Assignment of Trademark") and correct inadvertent errors to the applicant's and original registrant's entity designation.

Diversified Suburban Newspapers, Inc.'s assignment of the THE PARK RECORD mark, Registration No. 2,384,815 (the "Registered Mark") to Utah Media, Inc. as reflected in the Assignment of Trademark was intended to reflect a name change of the owner of the Registered Mark. On January 26, 2005, Diversified Suburban Newspapers, Inc., who in (i) the application and resulting registration for the Registered Mark, and (ii) the Assignment of Trademark, was inadvertently and incorrectly identified as a Utah corporation when it in fact was a Delaware corporation (which error was a correctable error pursuant to §1609.10 and §1201.02(c) of the Trademark Manual of Examining Procedure), changed its name from Diversified Suburban Newspapers, Inc. to Utah Media, Inc. as reflected in the Certificate of Amendment of Amended and Restated Certificate of Incorporation of Diversified Suburban Newspapers, Inc ("Certificate of Amendment") filed with the Delaware Division of Corporations (see Exhibit A).

By this Correction to Assignment of Trademark Agreement, the undersigned represents that there was an initial inadvertent and correctible error in the entity designation of Diversified Suburban Newspapers, Inc. which always was a Delaware corporation and not a Utah corporation. The undersigned further represents that Diversified Suburban Newspapers, Inc. changed its name to Utah Media, Inc., the current owner of the Registered Mark, by means of the attached Certificate of Amendment. The undersigned further represents that Diversified Suburban Newspapers, Inc., a Utah corp., did not exist as a legal entity at the time of filing.

of Delaware, does hereby certify as follows:

The name of the Corporation is Diversified Suburban Newspapers, Inc. and it was  
originally incorporated under the name Diversified Suburban Newspapers, Inc. and the  
Certificate of Incorporation was filed on June 11, 1984 with the Secretary of the State of  
Delaware. The original Certificate of Incorporation was amended on March 12, 1987 and  
amended and restated on December 21, 2004.

The Board of Directors of the Corporation, by unanimous written consent dated  
January 26, 2005, adopted resolutions pursuant to Section 242 of the General Corporation  
Law of the State of Delaware, setting forth amendments to the Certificate of  
Incorporation of the Corporation and declaring said amendments to be advisable. The  
sole stockholder of the Corporation duly approved said proposed amendments by written  
consent in accordance with Section 228 and 242 of the General Corporation Law of the  
State of Delaware. The resolutions setting forth the amendments are as follows:




