ASSIGNMENT OF TRADEMARKS

Whereas, Ardell International, Inc. ("Assignor"), a California Corporation, with an address at 2220 Gaspar Avenue, Los Angeles, California, is the owner of the trademark listed on Schedule A attached ("the Trademark").

Assignor irrevocably grants, sells, transfers, assigns and delivers to Assignee, all right, title and interest of every kind and character throughout the world that it has in and to the Trademark and the goodwill of the business pertaining thereto, including the right to and all claims for past damages, it being acknowledged and understood that it is the intention of this assignment to confer upon Assignee, Assignor's full and complete title to and ownership of the Trademark, for its life, or any term allowed by the law of the jurisdiction of its registration.

2. WARRANTIES: Assignor represents and warrants:

2.1 Assignor is the owner of the Trademark free and clear of any lien, encumbrance, claim or challenge, and the registration is duly perfected, fully paid to date, and in good standing.

2.2 Assignor has not previously assigned its ownership, right, or title, in whole or in part to the Trademark to any other person.

3. RIGHTS AND OBLIGATIONS:

3.1 Assignor agrees to execute and deliver or cause to be executed and delivered to Assignee for the Trademark or any purchaser of the Trademark from Assignee any and all documents and instruments, in form and substance reasonably satisfactory to Assignee and its counsel, necessary to effect and complete the transfer, grant or sale to Assignee of all rights or property acquired or intended to be acquired by Assignee under this Agreement and shall pay any fees or expense found due and owing prior to the date of this Assignment.


4. ASSIGNMENT OF WARRANTIES:
