CONFIRMATORY DEED OF TRADEMARK ASSIGNMENT

THIS CONFIRMATORY DEED OF TRADEMARK ASSIGNMENT (this "Assignment"), is made between **Manifattura Lane Gaetano Marzotto & Figli S.p.A.**, an Italian Joint Stock Company ("Assignor"), and **Marzotto Lab S.r.l.**, an Italian Limited Liability Company ("Assignee").

WHEREAS, Assignor is the registered owner of, and has assigned to Assignee by Deed dated December 15, 2014 effective as of January 1, 2015 (the "Effective Date"), all right, title and interest in and to: (i) any and all trademark, and intellectual property rights, including rights of priority, and the US trademark registrations and applications for the marks/names identified on Exhibit A attached hereto ("the Marks"); and (ii) any and all goodwill of the business associated with the Marks;

WHEREAS, Assignee has acquired the Marks and any and all goodwill of the business associated therewith from Assignor, subject to the terms and conditions of this Assignment; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Marks and goodwill to Assignee.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby confirms having assigned, transferred and conveyed to Assignee all right, title and interest in and to the Marks, together with: (i) the goodwill symbolized by the Marks; (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Marks; and (iii) any royalties or other consideration owed in connection with use of the Marks after the Effective Date.
2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks, goodwill and all other rights hereby conveyed.
3. Subject to the terms hereof, Assignee accepts such assignment of the Marks and goodwill.


