**TRADEMARK ASSIGNMENT
(AON HEALTH COVERAGE RESOURCES)**

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into and effective as the date signed below ("Effective Date") by and from Hewitt Associates LLC, a Illinois limited liability company with an address of 4 Overlook Point Lincolnshire, IL 60069 ("Hewitt Associates") to Aon Corporation, a Delaware corporation with an address of 200 East Randolph Street Chicago, IL 60601 ("Aon Corporation").

NOW, THEREFORE, Hewitt Associates agrees as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Hewitt Associates hereby assigns, transfers and conveys to Aon Corporation, absolutely and in perpetuity, all of Hewitt Associates' entire right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, including the pending application for the Trademark, as well as any and all claims, demands, causes of action, rights to sue or other rights occasioned from or because of any and all past infringement of such Trademark and the right to collect damages therefor, as of the Effective Date.

2. Further Assurances. Hewitt Associates agrees to cooperate at all times from and after the date hereof with respect to the supplying of any information reasonably requested by Aon Corporation hereto regarding any of the matters described in this Assignment, and Hewitt Associates agrees to execute such other instruments or documents as may be reasonably requested for the purpose of giving effect to, evidencing or giving notice of any conveyance, assignment, and transfer described herein.

3. Successors and Assigns. This Assignment is binding on Hewitt Associates, its successors and assigns, and will inure to the benefit of Aon Corporation, its successors and assigns. Nothing in this instrument, express or implied, is intended or shall be construed to confer upon, or give to, any person, corporation or entity other than Aon Corporation, its successors and assigns, any remedy or claim under or by reason of this instrument, or any terms, covenants or conditions hereof, and all the terms, covenants and conditions in this instrument shall be for the sole and exclusive benefit of Aon Corporation and its successors and assigns.
