## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of November 30, 2015 (this "Release") is made by Comerica Bank, as Agent (the "Secured Party") under the Security Agreement dated December 19, 2012 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Intercept Interactive Inc. WHEREAS, pursuant to the Security Agreement and IP Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtors' trademarks, including the trademarks listed on the attached Exhibit A (the "Trademarks").



NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks under the Security Agreement and the IP Security Agreement.
