RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of November 30, 2015 (this "Release") is made by Comerica Bank, as Agent (the "Secured Party") under the Security Agreement dated December 19, 2012 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Intercept Interactive Inc. (the "Debtor") and the Agreement (Trademark) dated December 19, 2012 by and among the Secured Party and the Debtor (the "IP Security Agreement"), such IP Security Agreement recorded in the records of the United States Patent and Trademark Office on December 21, 2012 at Reel 4926, Frame 845.

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtors' trademarks, including the trademarks listed on the attached Exhibit A (the "Trademarks").


WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to the Debtor and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement and IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks under the Security Agreement and the IP Security Agreement.
