SECURITY INTEREST ASSIGNMENT

This SECURITY INTEREST ASSIGNMENT (“ Agreement”), dated as of November 30, 2015, is made by and between PACIFIC WESTERN BANK (as successor in interest by merger to Square 1 Bank, “Assignor”), in favor of Gary S. Holmes Revocable Trust, VCI TXI, LLC, William C. Wilemon, and Jagi Gill (collectively, “Assignees”).


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignees and their successors and assigns, and Assignees hereby accept, all of Assignor’s right, title and interest in and to the certain security interest issued to Assignor by TENEX HEALTH, INC. pursuant to the Intellectual Property Security Agreement dated October 5, 2015 (“IP Agreement”) between Assignor and TENEX HEALTH, INC., including, without limitation, the security interest in the intellectual property listed on Exhibits A, B and C of the IP Agreement.
2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office, the Register of Copyrights in the United States Copyright Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Agreement upon request by any Assignee. Following the date hereof, upon an Assignees’ reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignees and their successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the assignment hereunder to Assignees, or any assignee or successor thereto.
3. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.


