**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of November 19, 2015 and granted by ROS ACQUISITION OFFSHORE LP, as the administrator ("Administrator") (together with its successor(s) thereto in such capacity, the administrator for each of the Lenders, under the Security Agreement referred to below, in favor of AEROCRINE AB (PUBL), a Swedish limited liability company, with registration number 556549-1056 ("Grantor").

WHEREAS, Administrator and Grantor entered into a Trademark Security Agreement, dated as of April 29, 2013 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on May 2, 2013, at Reel 5048, Frame 0932, pursuant to which Grantor granted to Administrator, by way of a first mortgage and security interest, a security interest having priority over all other security interests, to all of Administrator's right, title and interest in and to the Trademarks (as defined in the Security Agreement) referred to in Schedule A thereto, and identified in Schedule A to this RELEASE, and all good will associated with the Trademarks and Licenses; and,


WHEREAS, Grantor has promptly paid and performed all its Secured Obligations (as defined in the Security Agreement), and Administrator desires to release its security interests in and liens upon the Trademark rights and Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrator hereby releases its lien on and security interest in all Grantor's right, title and interest in and to the Trademarks and Licenses and reassigns any and all interest it may have in such Trademarks and Licenses to Grantor.
