**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, on August 9, 2012, the Grantor and General Electric Capital Corporation entered into a Intellectual Property Security Agreement (First Lien) ("Security Agreement");

WHEREAS, pursuant to said Security Agreement, the Grantor granted to General Electric Capital Corporation, among other collateral, a continuing security interest in all of each Grantor's right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on August 13, 2012, at reel/frame 4840/0684;

WHEREAS, General Electric Capital Corporation assigned its interest in the Trademarks to the Administrative Agent, pursuant to the Assignment of Intellectual Property Security Agreement dated as of August 21, 2015 ("Assignment");

WHEREAS, said Assignment was recorded in the United States Patent & Trademark Office on August 25, 2015, at reel/frame 5608/0499; and


