## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 2, 2015, is by MCDS VENTURES LLC, an Indiana limited liability company (the "Grantor"), in favor of MONROE CAPITAL MANAGEMENT ADVISORS, LLC, a Delaware limited liability company ("Monroe"), as servicing agent and as administrative agent (in such capacity, the "Administrative Agent").

This Agreement refers to (a) that certain Credit Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among NELBUD SERVICES GROUP, INC., a New Jersey corporation (the "Company"), each subsidiary of the Company, if any, that from time to time becomes a party thereto as a borrower (together with the Company, the "Borrowers"), the financial institutions that are or may from time to time become parties thereto as lenders (the "Lenders") and Monroe, as servicing agent and as administrative agent for the Lenders, pursuant to which the Lenders have agreed to make loans to the Borrowers; and (b) that certain Guaranty and Collateral Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement"), by and among the Borrowers, the other Persons who are or become "Grantors" thereunder and Monroe, as servicing agent and as administrative agent for the Lenders. Unless otherwise defined herein, all capitalized terms used herein shall have the respective meanings ascribed to them in the Credit Agreement or the Guaranty and Collateral Agreement, as applicable.

Pursuant to the Guaranty and Collateral Agreement, the Grantor has granted to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in substantially all of its assets, including all of its right, title and interest in, to and under all now owned and hereafter acquired Trademarks (as defined below), Trademark applications and Trademark Licenses (as defined below) and all products and proceeds thereof, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Grantor Obligations. Pursuant to the Guaranty and Collateral Agreement, the Grantor is required to execute and deliver to the Administrative Agent, for the ratable benefit of the Lenders, this Agreement.

In consideration of the mutual agreements set forth herein and in the Guaranty and Collateral Agreement, the Grantor does hereby grant to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired:

- (1) each Trademark and Trademark application, including, without limitation, each Trademark and Trademark application referred to in Schedule 1, together with any renewals thereof and all goodwill associated therewith (excluding any "intent to use" Trademark application for which a statement of use has not been filed and accepted with the United States Patent and Trademark Office);
- (2) each written agreement naming the Grantor as licensor on the date hereof, which grants any right to use any Trademark (each, a "Trademark License");
- (3) all products and Proceeds of the foregoing, including, without limitation, any royalties or any claim by the Grantor against third parties for past, present or future infringement of any Trademark, including, without limitation, any Trademark referred to in Schedule 1 and any Trademark issued pursuant to a Trademark application referred to in Schedule 1 (items (1), (2) and (3) being herein collectively referred to as the "Trademark Collateral").

This security interest is granted in conjunction with the security interests granted to the Administrative Agent pursuant to the Guaranty and Collateral Agreement and subject to limitations set forth therein and in the Credit Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guaranty and Collateral Agreement, the terms and provisions of each of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Guaranty and Collateral Agreement, the provisions of the Guaranty and Collateral Agreement shall control.

As used in this Agreement, the capitalized terms “Proceeds” and “Trademarks” are as defined in the Guaranty and Collateral Agreement. Those definitions, in relevant part, *mutatis mutandis*, are provided below for convenience only and do not affect the construction of this Agreement, the Credit Agreement or the Guaranty and Collateral Agreement:

“Proceeds” means all “proceeds” as such term is defined in Section 9-102(a)(64) of the UCC and, in any event, shall include all dividends or other income from the Investment Property, collections thereon or distributions or payments with respect thereto.

“Trademarks” means (a) all trademarks, trade names, corporate names, each of the Grantor’s names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith (other than any “intent-to-use” applications), whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, and (b) the right to obtain all renewals thereof.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original and together shall constitute one and the same agreement. Facsimile or electronic copies of the signatures to this Agreement shall be deemed to be originals and may be relied upon to the same extent as the originals.


