## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made and effective as of Oct 29, 2015 (the "Effective Date") by WILMINGTON TRUST COMPANY ("Administrative Agent"), a banking and trust company having a mailing address at 50 South State Street, Suite 1290, Minneapolis, Minnesota 55402, in its capacity as successor Administrative Agent for the Secured Party pursuant to that certain Credit Agreement dated July 31, 2006 (the "Credit Agreement"), as from time to time amended, extended, renewed, supplemented, or otherwise modified, by and among CIT LENDING SERVICES CORPORATION ("CIT"), a Delaware corporation, as the Administrative Agent; the Lenders (as defined in the Credit Agreement) from time to time party to the Credit Agreement; and LEGENDS GAMING, LLC ("Grantor"), a Delaware limited liability company having a mailing address at 3990 Washington Street, Vicksburg, Mississippi 39180.

WHEREAS, pursuant to the terms and conditions of the Credit Agreement, Grantor entered into that certain Trademark Security Agreement dated July 31, 2006 (the "Trademark Security Agreement"), by and between Grantor and CIT as the administrative agent for the benefit of the Secured Party (as defined in the Trademark Security Agreement) (the "Secured Party"), wherein Grantor granted to the Secured Party a security interest in all of the Collateral (as defined in the Trademark Security Agreement) (the "Collateral"), which Collateral included without limitation the trademark registrations and applications set forth on Schedule I to this Release;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office ("PTO") at Reel 003381, Frame 0773, on August 31, 2006;

WHEREAS, pursuant to that certain "Order Appointing Wilmington Trust Company as Successor Administrative Agent and Granting Related Relief" entered on May 20, 2008 (the "Order"), by the U.S. Bankruptcy Court for the Western District of Louisiana, Shreveport Division, in the action *In re Louisiana Riverboat Gaming Partnership, et al.*, Bankruptcy Chapter 11 Case No. 08-10824, CIT was terminated as the administrative agent under the Credit Agreement, and Administrative Agent was appointed as the successor Administrative Agent under the Credit Agreement, and was vested with all the rights, powers, privileges, and duties of the Administrative Agent under the First Lien Loan Documents (as defined in the Order);

WHEREAS, the Order was recorded in the PTO at Reel 004763, Frame 0241 on April 24, 2012;

WHEREAS, Grantor has requested that the Administrative Agent enter into this Release, in order to accomplish and evidence the release of the security interest in the Collateral granted in the Trademark Security Agreement, and the reassignment of any and all right, title and interest in and to the Collateral that the Administrative Agent or the Secured Party may have in the Collateral pursuant to the Trademark Security Agreement; and

WHEREAS, Administrative Agent, on behalf of itself and the Secured Party, has agreed to terminate and release the security interest in the Collateral granted in the Trademark Security Agreement, and to reassign any and all right, title and interest in and to the Collateral that the Administrative Agent or the Secured Party may have in the Collateral pursuant to the Credit Agreement or the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of itself and the Secured Party, and their respective successors, legal representatives, and assigns, hereby terminates, cancels, releases, and discharges the security interest in the Collateral granted in the Trademark Security Agreement, and reassigns and transfers to Grantor any and all right, title and interest in and to the Collateral that the Administrative Agent and the Secured Party may have in the Collateral pursuant to the Credit Agreement or the Trademark Security Agreement, if and to the extent such may have been acquired.

Administrative Agent shall take all further actions, and provide to Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
