RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

BODEK AND RHODES, INC., a Pennsylvania corporation ("Grantor"), whose address is 2951 Grant Ave., Philadelphia, Pennsylvania, executed a Trademark Security Agreement dated as of May 20, 1998 in favor of PNC Bank, National Association, as Agent for the benefit of certain lenders ("Agent"), whose address is 1600 Market Street, Philadelphia, Pennsylvania, as amended by that certain First Amendment to Trademark Security Agreement dated as of December 21, 2007 executed by Grantor and Agent (as amended from time to time, the "Security Agreement").

Agent wishes to release and retransfer to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Released Marks, and the goodwill associated therewith.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any.
