TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Trademark Assignment") is made by and between:

TOM MORRIS LIMITED, a Limited Company organized and existing under the laws of Scotland (registered number SC009529) and having its registered office at Pilmour House, St Andrews, Fife KY16 9SF, United Kingdom ("Assignor") and;

ST ANDREWS LINKS LIMITED, a Limited Company organized and existing under the laws of Scotland (registered number SC141590) and having its registered office at Pilmour House, St Andrews, Fife KY16 9SF, United Kingdom ("Assignee").

Both Assignor and Assignee shall be referred to as the "Parties" when used collectively.

WHEREAS, Assignor is the owner of record of the trademark registrations and applications in various jurisdictions for the word and design marks that are set forth in the attached Schedule 1 of this Trademark Assignment along with the common law rights thereto (hereinafter the "Tom Morris Marks");

WHEREAS, Assignor and Assignee are desirous of executing said Trademark Assignment;

WHEREAS, Assignor hereby represents and warrants that the Tom Morris Marks are valid and in full force and effect;

WHEREAS, Assignor hereby represents and warrants that it has the right, power and authority to enter into this Trademark Assignment and assign the said Tom Morris Marks to Assignee;

WHEREAS, Assignor has agreed to assign to Assignee all of the rights, title, and interests of the Assignor in and to the Tom Morris Marks and the goodwill and common law rights associated therewith, and Assignee has agreed to accept said assignment; and

WHEREAS, the Parties have agreed to enter into this Trademark Assignment, which shall take effect on the last date of signing ("the Effective Date").

NOW, THEREFORE, for good and valuable consideration of the sum of £10, now paid by the Assignee to the Assignor, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

Assignor hereby irrevocably assigns, transfers, and conveys to Assignee, and Assignee hereby accepts from the Assignor, all of Assignor's full and complete right, title and interest in and to the said Tom Morris Marks, all rights appurtenant thereto, and all common law rights associated therewith, together with the goodwill associated with said Tom Morris Marks.

Assignor further assigns to Assignee all rights to sue for, recover from and receive all damages and remedies, at Assignee's discretion, occurring from past, present and future infringing or misappropriating uses of the Tom Morris Marks by any third-party.


Assignor further agrees to assist Assignee at Assignee's reasonable expense in providing any documentation, pictures, drawings, specimens and/or any other information Assignee may need to finalize, maintain, or renew the registrations for the Tom Morris Marks, defend the registrations/applications for the Tom Morris Marks, and/or otherwise perfect or maintain the rights thereto and to enforce rights to the Tom Morris Marks and the registrations/application therefore against any third-party infringer.
