**CERTIFICATE OF AMENDMENT

The undersigned, for purposes of amending the Certificate of Incorporation (the "Certificate") of Roll Call, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

**FIRST:** The name of the Corporation is Roll Call, Inc. (the "Corporation").

**SECOND:** The Certificate was filed with the Office of the Secretary of State of the State of Delaware on December 4, 1992.


**THIRD:** That Article First of the Certificate is hereby amended to read, in its entirety, as follows:
