**TERMINATION OF TRADEMARK SECURITY AGREEMENT AND  
RELEASE OF LIENS AND SECURITY INTEREST IN TRADEMARKS**

This TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF LIENS AND SECURITY INTEREST IN TRADEMARKS (this "*Release*") is made as of December 3, 2015 by CoBank, ACB, as Collateral Agent (the "*Collateral Agent*") for the Lenders referenced therein (collectively, the "*Lenders*").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of August 28, 2003, as the same may have been amended, restated, supplemented or otherwise modified from time to time (the "*Security Agreement*"), House of Raeford Farms, Inc., a North Carolina corporation (the "*Company*"), granted to the Lenders a security interest (the "*Security Interest*") in the trademark and trademark application set forth on Exhibit A (the "*Trademark*");

WHEREAS, the Security Interest was recorded at Reel 2714, Frame 0909, on September 12, 2003, with the United States Patent and Trademark Office; and

WHEREAS, the Company has requested that the Collateral Agent, on behalf of the Lenders, release all liens on and security interest in the Trademark.


