**TRADEMARK ASSIGNMENT**

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Assignor hereby conveys and assigns to Assignee, its successors and assigns, the entire right, title and interest in, to and under the Francap Marks, including common law rights therein, together with all goodwill of the business represented and symbolized by and associated with the Francap Marks.

Assignor further conveys, transfers and assigns to Assignee the right to file any action and recover damages by reason of past infringement, misappropriation or other unauthorized use of said Francap Marks, with the right to sue for, and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns, or other legal representatives.

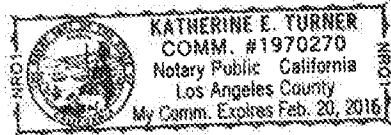
