TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "*Assignment*") is made as of November 18, 2015 (the "Effective Date"), by and between Healogram, Inc., now known as Parable Health, Inc., a Delaware corporation, 222 Broadway, 19th floor, New York, New York 10038, ("*Assignor*"), and eClinicalWorks, LLC, a Massachusetts limited liability company, 2 Technology Drive, Westborough, Massachusetts 01581 ("*Assignee*").

WHEREAS, Assignor is the owner of the entire right, title, and interest in, to, and under the following United States trademark registrations for the mark HEALOGRAM:

U.S. Reg. No. 4,838,032; 4,838,033; 4,838,034; and 4,838,035

and the goodwill associated with all of the foregoing (collectively, the "*Trademarks*"); and

WHEREAS, the parties have had a dispute regarding whether the *Trademarks* infringe on Assignee's rights in its registered mark HEALOW (U.S. Reg. No. 4,633,422) and related marks containing same, and wish to amicably resolve that dispute through, among other things, Assignor transferring its right, title, and interest in and to the Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Assignor hereby irrevocably sells, assigns, transfers, and sets over to Assignee all of Assignor's right, title, and interest in and to the Trademarks, together with the goodwill of the business related to the Trademarks, and all registrations, renewals, and extensions of the foregoing, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, as of the Effective Date or thereafter.

Assignor authorizes and requests the United States Commissioner of Patents and Trademarks and any other similar government authority to record Assignee as owner of the Trademarks and issue any and all registrations issued thereon to Assignee, as assignee of the entire right, title, and interest in, to, and under the same, for the sole use and enjoyment of Assignee and its successors, assigns, or other legal representatives.

Assignor shall provide Assignee, its successors, assigns, or other legal representatives, cooperation and assistance at Assignee's request as may be reasonably required in the implementation or perfection of this Assignment.
