RELEASE AND REASSIGNMENT OF  
TRADEMARKS AND TRADEMARK APPLICATIONS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and releases, retransfers and reassigns to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Trademark Collateral and the goodwill associated therewith.

Agent hereby authorizes Grantor and its agents, representatives and designees to record this Release and Reassignment of Trademarks and Trademark Applications with the United States Patent and Trademark Office. Agent agrees to provide Grantor with any additional authorization and documentation reasonably necessary to effect the release of the Agent's security interest in the Trademark Collateral.
