RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, FXI, INC., a Delaware corporation (f/k/a Foamex Innovations Operating Company) (“Grantor”) granted a continuing security interest in and lien upon certain trademarks and related rights to WELLS FARGO BANK, NATIONAL ASSOCIATION, as Agent (“Agent”), as set forth in the Supplemental Trademark Collateral Assignment and Security Agreement, dated December 17, 2010, between Grantor and Agent (the “Trademark Security Agreement”);

2. agrees that any power of attorney or similar rights granted by Grantor to Agent pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
