

TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "<u>Agreement</u>") is made as of December 2, 2015, by FDS ACQUISITION, INC., a Delaware corporation ("<u>Assignor</u>") in favor of WELLSPRING PHARMACEUTICAL CORPORATION, a Delaware corporation ("<u>Assignee</u>").

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, effective as of the date hereof, by and between Assignor, Assignee and Inspired Beauty Brands, Inc. (the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement, Assignor has sold, conveyed, assigned, and transferred to Assignee, and Assignee has acquired from Assignor, all of Assignor's right, title and interest in, to and under the trademarks set forth on Schedule A and Schedule B, (collectively, the "Trademarks"), together with the goodwill of the business connected with and symbolized by the Trademarks, and the parties wish to record such acquisition in the United States Patent and Trademark Office (the "PTO") and corresponding Governmental Entities in any other applicable jurisdiction; and

WHEREAS, capitalized terms used herein but not otherwise defined shall have the meanings ascribed to such terms in the Purchase Agreement.

NOW, THEREFORE, in consideration of the foregoing and in consideration of the mutual promises, covenants, representations, warranties and agreements contained herein and in the Purchase Agreement, Assignor and Assignee agree as follows:

- Assignment. Effective as of the date hereof, and pursuant to the Purchase Agreement, Assignor hereby sells, conveys, assigns, and transfers to Assignee all of Assignor's right, title and interest in, to and under the Trademarks in the United States and throughout the world, together with the goodwill of the business connected with and symbolized by the Trademarks, including, without limitation, all registrations and applications therefor, which may include applications filed on the basis of applicant's bona fide intent to use the subject marks, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside of the United States based in whole or in part upon the Trademarks, and all corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter arising or in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Agreement had not been made, together with the right to collect royalties, products and proceeds in connection with any of the foregoing and the right to sue for past, present or future infringement, misappropriation, unfair competition, dilution or other violation thereof and to collect and retain all damages and profits related to the foregoing, and any priority right that may arise from any such Trademarks.
- 2. <u>Recording</u>. This Agreement has been executed and delivered by Assignor to Assignee for the purpose of recording this Agreement with the PTO or other Governmental

Entities, and the parties hereby authorize the PTO or such other Governmental Entities to record this Agreement.

- 3. <u>Further Assurances</u>. From time to time following the date hereof, at the sole expense of Assignee, Assignor shall execute and deliver such other instruments of conveyance, assignment, transfer and delivery and execute and deliver such other documents and take or cause to be taken such other actions as necessary or as Assignee reasonably may request in order to record, perfect or otherwise effectuate the assignment granted hereunder.
- 4. <u>Successors</u>. This Agreement and all of the provisions hereof will be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. <u>Counterparts</u>. This Agreement may be executed in one or more counterparts (including by means of telecopied portable document format (pdf) signature pages), any one of which need not contain the signatures of more than one Party, but all such counterparts taken together shall constitute one and the same agreement.
- 6. <u>Governing Law</u>. All questions concerning the construction, validity and interpretation of this Agreement (and all schedules and exhibits hereto) will be governed by and construed in accordance with the internal laws of the State of New York, without giving effect to any choice of law or conflict of law provision that would cause the application of the laws of any jurisdiction other than the State of New York.
