WHEREAS, ASSIGNOR declares that on October 12, 2012 it assigned, sold and transferred to the ASSIGNEE all right title and interest in and to all inventions and patent applications and issued patents ("the Technology") as described in Exhibit A and the trademarks ("the Marks") and other intellectual property ("the Property") as described in Exhibit B, attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the goods on which the Marks are used ("the Products").


