**CERTIFICATE OF AMENDMENT  
OF THE  
FIFTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
SEEGRID CORPORATION**

Seegrid Corporation, a corporation organized and existing under the General Corporation Law of the State of Delaware (the "DGCL"), hereby certifies as follows:

**FIRST:** The name of this corporation is Seegrid Corporation (the "Corporation"), which was originally incorporated pursuant to the DGCL on February 20, 2003.

**SECOND:** The Fifth Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on April 27, 2012, and subsequently amended on November 7, 2012, March 4, 2013, May 9, 2013, June 21, 2013 and January 21, 2014 (as amended, the "Charter").

**THIRD:** On October 21, 2014, the Corporation filed a voluntary petition for relief under Chapter 11 of Title 11 of the United States Bankruptcy Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") (Case No. 14-12391).

**FOURTH:** The Corporation's Board of Directors, by unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution proposing and declaring advisable to amend Article I of the Charter as set for in this Amendment to the Charter (this "Amendment").

**FIFTH:** Article SEVENTH of this Amendment has been deemed approved without the need for board of directors or stockholder approval pursuant to Section 303 of the DGCL because it has been adopted pursuant to the Plan of Reorganization of the Corporation, as confirmed on January 20, 2015, by order (the "Order") of the Bankruptcy Court.

**SIXTH:** This Amendment has been duly executed and acknowledged by an officer of the Corporation designated by the Order in accordance with the provisions of Sections 242 and 303 of the DGCL.

**SEVENTH:** Article I of the Charter is deleted in its entirety and replaced with the following:

**"ARTICLE I**

The name of the corporation is Seegrid Holding Corporation."

**EIGHTH:** The following shall be added to the Charter as Article IV, C:

"C. NONVOTING STOCK.


1. No Nonvoting Equity Securities. Notwithstanding anything to the contrary in this Fifth Amended and Restated Certificate of Incorporation, the Corporation shall not issue nonvoting equity securities to the extent prohibited by Section 1123(a)(6) of the Bankruptcy Code (11 U.S.C. § 1123(a)(6)). The prohibition on the issuance of nonvoting equity securities is included in this Fifth Amended and Restated Certificate of incorporation in compliance with Section 1123(a)(6) of the Bankruptcy Code (11 U.S.C. § 1123(a)(6))."

NINTH: This Certificate of Amendment of the Fifth Amended and Restated Certificate of Incorporation shall become effective upon filing in the office of the Secretary of State of the State of Delaware.
