TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is effective as of the 24th day of November 2015, by and between Razor USA LLC, a Delaware limited liability company, having a place of business at 12723 166th Street, Cerritos, California 90703 (hereinafter referred to as "ASSIGNEE"), and VIZIO, Inc., a California corporation, having a place of business at 39 Tesla, Irvine, California 92618 (hereinafter referred to as "ASSIGNOR").

WHEREAS, ASSIGNOR has adopted, used, is using, and is, to the best of its knowledge and belief, the owner of the trademark listed in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (hereinafter collectively referred to as "Mark") worldwide;

WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to the Mark and Application in the U.S. that ASSIGNOR may have in the Marks and Applications, together with the goodwill and business associated therewith; and

WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Mark and Application, together with the goodwill and business associated therewith;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (1) the Mark set forth in Schedule A; and
- (2) the Application set forth in Schedule B;

together with the goodwill symbolized by the Mark and Application as well as other registered or unregistered trademarks for the Mark owned or used anywhere in the world by ASSIGNOR, concurrent with the transfer of the goodwill and business associated therewith, including without limitation any and all claims or causes of action for infringement, royalties, or damages concerning the Mark that may have existed before the date of this Agreement or which may arise in the future.

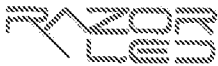
