GRANT OF A SECURITY INTEREST – TRADEMARKS

This Trademark Security Agreement (this "Trademark Security Agreement") is effective as of January 16, 2014, by Soil Retention Systems, Inc., a California corporation ("Grantor"), in favor of Pacific Western Bank, a California corporation, (together with its successors and assigns in such capacity, "Lender").

WHEREAS, Grantor agrees to take whatever actions are requested by Lender to perfect and continue Lender's security interest in the Trademark Collateral.

NOW, THEREFORE, as collateral security for the payment, performance and observance of all of the secured obligations, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby confirms and otherwise reaffirms its pledge and grant of a continuing security interest in the Trademark Collateral to the Lender.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Lender with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, the Grantor has caused this Trademark Security Agreement to be duly executed by its officer thereunto duly authorized as of the date first set forth above.
