- I, B.K.S.IYENGAR of Pune, Indian Inhabitant, aged 94 years, residing at 1107/B-1, Hare Krishna Mandir Road, Shivaji Nagar Pune do hereby revoke all previous wills or testamentary writings that I have made before and declare this to be my last will and Testament.
- I appoint my daughter Geeta, and my son Prashant to be the Executrix and Executor of my will. They shall hereafter be called "My Executors".
- 3. I hereby authorize and direct my Executors to spend such amount as they may deem fit for my funeral and other obsequial ceremonies. They shall not be bound to render any account to any one in respect of the amounts so spent by them.
- 4. I direct my Executors to collect all my estate and pay debts if any due and owing by me or by my estate to anyone at the time of my demise. My executors shall also pay and discharge any taxes if payable in respect of my estate.
- 5. I direct my Executors to apply for and obtain Probate of my will if required and incur all necessary costs, charges and expenses for obtaining probate. My executors shall be authorized to incur all

necessary costs, charges and expenses in relation to my estate and for collection of my estate.

6. "I desire that the yoga Institute started by me shall continue to run efficiently during my lifetime and during the lifetime of Geeta and Prashant. I direct them that during their lifetime or the life time of survivor of them they shall create a trust in which the members of my family shall be taken as trustees who shall be willing to act as such trustees. This will also include my grandchildren and other descendants. They shall be at liberty to appoint my grand children and their descendants and any other persons outside my family as Trustees for running the institute. They shall create a corpus for running the institute. The trust shall employ teachers and other persons to see that the institute runs, properly, smoothly and efficiently."

7. I am the owner of a one-third share in the land and the building situated at Pune at Hare Krishna Mandir Road and which is known as Ramamani Iyengar Memorial Yoga Institute. There are two buildings, One yoga Institute and the other residential house. I devise and bequeath my one third share, right, title and interest in the land at Hare Krishna Mandir Road and the two buildings with furniture, fixtures, articles and things lying therein to my daughter Geeta and my son Prashant equally and absolutely. I have received several gifts and prizes in appreciation of my services in teaching and propagating Yoga for more than 75 years. They shall form part of my bequests to my daughter Geeta and to my son Prashant equally and will form part of the archives and fixed in the institute.

8. I am a partner in the firm named "The Ramamani lyengar Memorilal Yoga Institute" carrying on training for pupils in Yoga, Asanas, Pranayam etc. I am having a one third share in the said firm. I devise and bequeath all my rights, title and interest in the said firm and the capital, profits,

ayam ucath goodwill of the said firm including amounts in the bank accounts and the cash to my daughter Geeta and son Prashant equally and absolutely.

9. I am entitled to royalties on books written by me and royalties on books that I may write in future. I bequeath 50% of my royalty rights in the books that I have written or that may be written in future by me to Bellur Krishnamachar and Seshamma Smaraka Niddhi Trust and the other 50% royalty rights to my daughter Geeta, son Prashant and my daughters Vanita, Sunita, Suchita and Savita equally. In the event of my daughter Geeta or my son Prashant not surviving me, her or his share will belong to the survivor of the two. In the event of my daughter Sunita not surviving me her share shall go to her husband K.V.Parthasarthi for life and then to Bellur Krishnamachar and Seshamma Smaraka Niddhi Trust. In the event of any other daughter not surviving me her share will belong to her child or children equally if more than one.

10. I am owner of shares of limited companies, taxable government bonds, non taxable government bonds, term deposits in Sundaram Finance, Housing development Finance Corporation, fixed deposits in banks, Mutual fund Bonds, Public Provident Fund scheme, post office saving scheme, U.T.I schemes, Bank accounts and other investments. I direct my executors to collect my monies as and when my investments mature or at any time they deem fit and collect the amounts from my reinvestments.


11. There is a Sri Ram Temple which was completely ruined in my village Bellur. After lot of efforts and struggle the Mujurai Department of Government of Karanataka gave me permission to reconstruct the said Sri Ram temple. I committed in public i.e the villagers of Bellur that I shall bear the entire cost of construction as the old Sri Ram Temple was built by my ancestors who were responsible for my valuable life. I have at my cost completed the reconstruction of the said Sri Ram Temple and the opening ceremony was on 23^{rd} November 2012 which is my birth day



according to the Indian Calendar. In this way I have discharged the obligation that I had made to the Villagers.

12. After collecting all the amounts due to me on my savings and investments and after incurring all cost, charges and expenses as well as taxation liabilities the net amount that will be available shall be utilized in payment of the following bequests:

- (a) A sum of Rs.10,00,000/- (Rupees Ten lacs only) to Smt. Ramamani Iyengar Charitable Trust as Corpus to the Charitable Trust. The net interest or income of the said amount shall be utilized for providing relief to the poor and down trodden people as well as to deserving poor students, educational Institutions, medical relief, development of our heritage, temple renovation, construction and maintenance of temple as well as for other objects of general public utility as my executors shall deem fit.
- (b) After paying the bequests mentioned in sub clause a, of clause 12 above I bequeath 50% of my balance savings and investments as corpus fund to the Bellur Krishnamachar and Seshamma Smaraka Niddhi Trust. The income or interest thereof shall be utilized for maintenance of the Trust's activities along with Yoga propagation in my centers in my village.
- (c) I bequeath the other 50% of my balance savings and investments to my children son Prashant and my daughters Geeta, Vanita, Suchita and Savita equally and absolutely.
- 13. I am also the owner of one seventh share in a land of 2 acres and 21 gunthas bearing S.Y. No.168/1 and No.168/2 situated at Singena Agraharam Village, Sajjapur Hoobli, Anekal Taluka, Bangalore Rural District. The other sharers are Geeta Iyengar, Prashant Iyengar, G

21 ma irai Shridharan, R.S.Shridhar, K.V. Parthasarthi and Savita Raghu. I devise and bequeath my share, right, title and interest in the said land to Geeta lyengar and Prashant lyengar equally. In the event of any one of the said two not surviving me then to the survivor of them absolutely.

14. I along with my daughter Geeta and my son Prashant have deposited sums in fixed deposits in favour of Ramamani Iyengar Memorial Yoga

Institute. The said amounts were received by all of us in respect of our share in the profits of the Partnership firm since a few years. A sum of nearly Rupees Two crores has been accumulated so far. We all shall keep continuing to deposit more in future in favour of Ramamani Iyengar Memorial Yoga Institute as we may deem fit. My share therein is one third. Similarly one third share therein is of daughter Geeta and one third share therein is of son Prashant.

15. I direct that the amounts of my one third share shall be treated as Corpus fund and the interest earned from the said Corpus fund shall be utilized to run the said Institute for a long time.

16. I bequeath the rest and residue of my net estate whatever the same may be and wherever the same may be found to my children Geeta, Prashant, Vanita, Sunita, Suchita and Savita equally and in the event of any one or more not surviving me then to the respective child or children of any such deceased daughter equally and in the event of any of my daughter dying without child or children her share will be distributed amongst all my living children equally. However in case of Geeta or Prashant predeceasing me his or her share shall belong to the survivor of them and on death of the survivor the said share shall belong equally to all my living children. In the event of any of my children not accepting the bequest made in his/her favour then the said bequest shall belong to Bellur Krishnamachar and Seshamma Smaraka Niddhi Trust.

17. I have made this will in my good and sound health and after fully understanding the same in all respects.
