WHEREAS, Titan Industries, Inc. is a California corporation with a business address of 5252 Bolsa Avenue, Huntington Beach, California 92649.

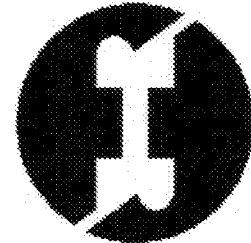
