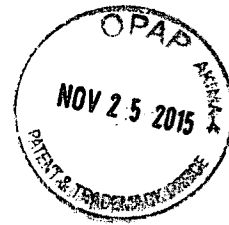

**RELEASE OF SECURITY INTEREST IN TRADEMARKS**



The Administrative Agent hereby authorizes Grantors, or Grantors' authorized representatives to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency.
