

NOTICE OF GRANT OF SECURITY INTEREST

SPORT OBERMEYER LTD., a Colorado corporation ("**Grantor**") and U.S. BANK NATIONAL ASSOCIATION ("**Bank**") entered into that certain Loan and Security Agreement, dated December 7, 2015 (as may be amended, modified, and restated "**Loan Agreement**").
