## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest is made as of November 30, 2015, by Healthcare Financial Solutions, LLC (as successor-in-interest to General Electric Capital Corporation), located at Two Bethesda Metro Center, Suite 600, Bethesda, Maryland 20814, as Administrative Agent ("ADMINISTRATIVE AGENT"), in favor of Spiracur Inc., a Delaware corporation, located at 1180 Bordeaux Drive, Sunnyvale, California 94089 (referred to as "COMPANY").

WHEREAS, COMPANY and ADMINISTRATIVE AGENT entered into (a) that certain Loan and Security Agreement dated as of October 30, 2014 (the "Loan Agreement") and (b) that certain Trademark Security Agreement dated as of October 30, 2014 (the "Security Agreement");

WHEREAS, pursuant to the Loan Agreement, COMPANY and ADMINISTRATIVE AGENT filed the Security Agreement with the U.S. Patent and Trademark Office, which was recorded on October 30, 2014 at Reel 005391 and Frame 0280-0286;

WHEREAS, under the Loan Agreement and the Security Agreement, COMPANY granted to ADMINISTRATIVE AGENT a certain security interest in, amongst other things, the COMPANY'S "Trademarks," as defined pursuant to the Security Agreement, which includes without limitation the trademarks described in Exhibit A (the "Collateral"); and

WHEREAS, COMPANY has satisfied all of its obligations to ADMINISTRATIVE AGENT under the Loan Agreement and the Security Agreement, and ADMINISTRATIVE AGENT wishes to release all interest that ADMINISTRATIVE AGENT may have in the Collateral.



1. The ADMINISTRATIVE AGENT hereby releases any and all of its right, title, and interest in and to the Collateral.
2. The ADMINISTRATIVE AGENT hereby reassigns, grants, and conveys to COMPANY all of the ADMINISTRATIVE AGENT'S right, title, and interest in and to the Collateral.

COMPANY hereby acknowledges that ADMINISTRATIVE AGENT's execution and delivery of this Release is made without recourse, representation, warranty or other assurance of any kind by ADMINISTRATIVE AGENT as to ADMINISTRATIVE AGENT's rights in any Collateral, the condition or value of any Collateral, or, except as expressly provided herein, any other matter.
