RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”) is made and effective as of December 4, 2015 and granted by Credit Suisse AG, Cayman Islands Branch (the “**Collateral Agent**”), as Administrative Agent and Collateral Agent for the secured parties under the Credit Agreement referred to below (the “**Secured Parties**”), in favor of Box, Inc., a Delaware corporation (the “**Grantor**”).

WHEREAS, pursuant to that certain Credit Agreement dated as of August 27, 2013 (the “**Credit Agreement**”) among the Grantor, the Lenders party thereto, and the Collateral Agent, the Grantor executed and delivered to the Collateral Agent (i) that certain Guarantee and Collateral Agreement by and between the Grantor and the Collateral Agent dated as of August 27, 2013 (the “**Master Security Agreement**”) and (ii) that certain Trademark Security Agreement by and between the Grantor and the Collateral Agent dated as of August 27, 2013 (the “**2013 Trademark Security Agreement**”) and that certain Trademark Security Agreement by and between the Grantor and the Collateral Agent dated as of November 30, 2014 (the “**2014 Trademark Security Agreement**”) and, together with the 2013 Trademark Security Agreement and the Master Security Agreement, the “**Security Agreements**”);

WHEREAS, pursuant to the Security Agreements, the Grantor pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the 2013 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005125, Frame 0305 on August 27, 2013 and the 2014 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005417, Frame 0264 on December 10, 2014; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Trademark Security Agreements and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the “**Trademark Collateral**”):

(a) each Trademark (as defined in the Master Security Agreement) owned by the Grantor, including, without limitation, each Trademark registration and application referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark;

(b) each Trademark License (as defined in the Master Security Agreement) to which the Grantor is a party, including, without limitation, each Trademark License identified in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark licensed pursuant thereto; and

(c) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Grantor against third parties for past, present or future unfair competition with, or violation of intellectual property rights in connection with or injury to, or infringement or dilution of, any Trademark owned by the Grantor (including, without limitation, any Trademark identified in Schedule 1 hereto), and all rights and benefits of the Grantor under any Trademark License (including, without limitation, any Trademark License identified in Schedule 1 hereto), or for injury to the goodwill associated with any of the foregoing..

2. Further Assurances. Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).


