**RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARKS AND TRADEMARK APPLICATIONS**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Wells Fargo Bank, National Association, in its capacity as administrative agent for certain financial institutions (in such capacity, "Agent"), does hereby certify that the continuing security interest it holds in the Grantors' (as defined herein) right, title and interest in, to and under those certain Trademarks and Trademark applications of Jones Parent LLC ("Parent"), JH Apparel Holdings LLC (formerly known as Jones Holdings LLC) ("Holdings"), JH Apparel (US) LLC (formerly known as Jones Apparel (US) LLC) ("JH Apparel") and Moda Nicola International LLC ("Moda" and together with Parent, JH Holdings and JH Apparel, each a "Grantor" and collectively, "Grantors"), granted to Agent pursuant to the Trademark Security Agreement, dated April 8, 2014, by and among Grantors and Agent, which was recorded in the United States Patent and Trademark Office on April 11, 2014, at Reel 5258, Frame 0510 and on March 5, 2015 at Reel 5472, Frame 0291 (the "Trademark Security Agreement"; all capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Trademark Security Agreement), which are identified on Exhibit A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby (collectively, the "Trademark Collateral"), is hereby released, relinquished and discharged with respect to each Grantor, and all right, title and interest in such Trademark Collateral previously assigned to Agent under the Trademark Security Agreement is hereby reassigned to Grantors, their successors and permitted assigns, without representation or warranty of any kind, nature or description; provided, that, nothing contained herein or otherwise shall be deemed a release or termination by Agent of any security interest in any other trademarks, trademark applications or other Trademarks granted by Grantors to Agent pursuant to the Trademark Security Agreement, all of which shall continue in full force and effect. The Agent hereby authorizes the Grantors or the Grantors' authorized representatives to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Agent agrees to execute and deliver to the Grantors, at the Grantors' expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.


