TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Trademark Assignment"), dated as of November 18, 2015, is made by Midtech R&D, Inc. ("Midtech"), a Minnesota corporation, located at 1120 Lake Avenue, Fairmont, Minnesota 56031, in favor of Southern States Cooperative, Incorporated. ("Southern States"), a Virginia corporation, located at 6606 West Broad Street, Richmond, Virginia 23230.

WHEREAS, Midtech owns a federal registration on the Principal Register of the United States Patent and Trademark Office ("USPTO") for use of the mark CO-ACTION WC PLUS with the following goods: "Adjuvant for use with agricultural chemicals." (U.S. Reg. No. 4801241) (the "CO-ACTION WC PLUS mark").

WHEREAS, Midtech has conveyed, transferred and assigned to Southern States the CO-ACTION WC PLUS mark, and has agreed to execute and deliver this Trademark Assignment, for recording with the USPTO.

AGREEMENT

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Midtech hereby irrevocably conveys, transfers and assigns to Southern States all of Midtech's right, title and interest in and to the CO-ACTION WC PLUS mark, together with the goodwill of the business connected with the use of, and symbolized by, the CO-ACTION WC PLUS mark, including:

(a) the trademark registration and all issuances, extensions and renewals thereof, along with all rights of any kind whatsoever of Midtech provided by applicable law; and

(b) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on or after the date hereof, including all rights to any claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Midtech shall be responsible for filing and recording this Trademark Assignment with the USPTO, at which point Southern States shall assume sole responsibility for the CO-ACTION WC PLUS mark. Midtech hereby authorizes the Commissioner for Trademarks in the USPTO to record and register this Trademark Assignment.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.

4. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


