**RELEASE OF SECURITY INTEREST IN

The Secured Party hereby TERMINATES, without recourse, representation or warranty the Trademark Security Agreement, and RELEASES, without recourse, representation or warranty its security interest in all of the Trademarks, including the trademark registrations set forth in Schedule I, attached hereto and incorporated herein by reference.

The Secured Party agrees to provide the Debtor with any additional authorization reasonably necessary to effect the release of the Debtor's security interest in the Trademarks.
