DEED OF ASSIGNMENT OF TRADE MARKS

PARTIES

HEALTH FOODS INTERNATIONAL LIMITED (NZBN 9429033682273), of cnr Kordel Place and Accent Drive, East Tamaki, Auckland, New Zealand (**Assignor**)

VITACO HEALTH IP PTY LIMITED (ACN 607 496 533) of Level 1, 82 Waterloo Road, North Ryde, New South Wales 2113 (**Assignee**)

INTRODUCTION


- A. The Assignor is the owner of all of the Trade Marks.
- B. The Assignor has agreed to assign, and the Assignee has agreed to accept, all rights, title and interests to the Trade Marks, subject to the terms and conditions of this deed.
- C. By a Trade Mark Assignment Deed dated 21 September 2015, the Assignor assigned to the Assignee all rights and interests in the Australian Musashi Trade Marks (**Assignment Deed**).
- D. The Assignor has also agreed to confirm the assignment of the Australian Musashi Trade Marks under the Assignment Deed.

COVENANTS

1. DEFINITIONS

1.1 In this deed, including the Introduction, the following words will have the following meanings:

Australian Musashi Trade Marks means the following Australian trade mark registrations:

Trade Marks means the trade marks (including the applications and registrations for those trade marks) set out in the Schedule (but excluding the Australian Musashi Trade Marks).

2. CONFIRMATION AND ASSIGNMENT

- 2.1 **Assignment:** In consideration of the sum of NZ\$1.00 paid by the Assignee to the Assignor and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby:
- (a) confirms the assignment to the Assignee of all of its rights, title and interest in and to the Australian Musashi Trade Marks under the Assignment Deed with effect from 21 September 2015;
 - (b) assigns to the Assignee absolutely all of its rights, title and interest in and to the Australian Musashi Trade Marks to the extent that the Assignor holds any such rights, title and interest as at the date of this deed; and
 - (c) assigns to the Assignee absolutely all of the Assignor's rights, title and interest in and to the Trade Marks with effect from the date of this deed.
- 2.2 **Further rights:** The assignments in clause 2.1(b) and (c) include, without limitation:
- (a) any copyright in the Australian Musashi Trade Marks and the Trade Marks or any other device or stylisation customarily used in association with the Australian Musashi Trade Marks and the Trade Marks, in all forms in which they have been used;
 - (b) the goodwill symbolised by and associated with the Australian Musashi Trade Marks and the Trade Marks including the whole of the goodwill arising from the use of those trade marks; and
 - (c) the assignment and transfer of all rights of action, powers and benefits arising from the ownership of the Australian Musashi Trade Marks and the Trade Marks including, without limitation, the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on or after the date of this deed.

3. EXECUTION OF DOCUMENTS

- 3.1 If requested by the Assignee, the Assignor will, at the Assignee's expense, execute all documents, give such assistance and do all other acts and things as may be necessary or desirable to give effect to the transfers and assignments in this deed and to enable the Assignee to prosecute, maintain, renew, enforce and defend the Trade Marks.

4. GENERAL


- 4.1 **Waiver:** No failure or delay by any party in exercising any right, power or privilege under this deed will operate as a waiver of such right, power or privilege, nor will any single or partial exercise preclude any other or further exercise of any right, power or privilege under this deed.
- 4.2 **Entire agreement:** This deed contains the whole of the contract and understanding between the parties relating to the matters covered by it and supersedes all prior representations, agreements, statements

and understandings between the parties relating to of those matters, whether verbal or in writing.

- 4.3 **Counterparts:** This deed may be executed in any number of counterparts (including facsimile or electronically scanned copies) all of which, when taken together, will constitute one and the same instrument. A party may enter into this deed by executing any counterpart. The parties acknowledge that this deed may be executed on the basis of an exchange of facsimile or electronically scanned copies and confirm that their respective execution of this deed by such means will be a valid and sufficient execution.
- 4.4 **Governing law:** The formation, validity, construction and performance of this deed will be governed by and construed in accordance with the laws of New Zealand. The parties irrevocably agree that the Courts of New Zealand will have non-exclusive jurisdiction to hear and determine all disputes under or in connection with this deed. The parties irrevocably waive any objections to New Zealand as the forum for proceedings on the grounds of forum non-conveniens or any similar grounds.


