## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Release of Intellectual Property Security Interest (the “**Release**”) is made and effective as of December 9, 2015 and granted by WEBSTER BANK, NATIONAL ASSOCIATION, a national banking association (the “**Secured Party**”), in favor of ECOSMART GREEN ENERGY PRODUCTS, INC., a Delaware corporation (the “**Grantor**”).

WHEREAS, by that certain Intellectual Property Security Agreement dated September 30, 2013, and recorded with the United States Patent and Trademark Office (the “**PTO**”) on October 9, 2013 at Reels/Frames 5128/0001 and 031393/0950 (the “**Intellectual Property Security Agreement**”), the Grantor collaterally assigned to the Secured Party a security interest in all of Grantor’s right, title and interest in, to and under certain “Collateral” (as defined in the Intellectual Property Security Agreement), including without limitation the trademark registration and issued patent identified in Schedule A attached hereto (the “**Intellectual Property**”); and

WHEREAS, the Secured Party has agreed to release such Intellectual Property Security Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby states as follows:

1. Release of Security Interest. Secured Party hereby terminates the Intellectual Property Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Intellectual Property Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, or to the Intellectual Property.


2. Assurances. Secured Party agrees, at the Grantor’s expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Recordation. The Commissioner of Patents and Trademarks is requested to amend the records of the PTO to reflect the release of the Intellectual Property Security Agreement herein.
