TRADEMARK ASSIGNMENT

WHEREAS, Harrison Dillon, an individual ("Assignor"), owns U.S. Trademark Application No. 86288873, filed May 22, 2014, for the service mark PHYLAGEN (the "Mark") for use with "scientific and technological services, namely, scientific research, analysis, testing, and assessment in the field of microbiology"; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns to Assignee as of the Effective Date all right, title and interest in and to the Mark worldwide, the application, and all rights associated therewith, together with the goodwill of the business symbolized thereby, as well as the ongoing and existing business of the Assignor to which the mark pertains.
