INTELLECTUAL PROPERTY RELEASE

THIS INTELLECTUAL PROPERTY RELEASE is made as of August 17, 2015, by BANK OF MONTREAL, as Collateral Agent (in such capacity, "Secured Party"), in favor of the Grantors (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Cbr Systems, Inc., a Delaware corporation and CBR Acquisition Holdings Corp., a Delaware corporation (each a "Grantor" and collectively the "Grantors") and Secured Party were parties to that certain Short Form Intellectual Property Security Agreement dated as of August 5, 2014 (the "Security Agreement") pursuant to which each Grantor granted a security interest to Secured Party in the Intellectual Property Collateral (as defined below) as security for certain obligations owing by each Grantor to Secured Party, including the Patents and Trademarks set forth on Schedules A and B, respectively, hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on August 5, 2014, at Reel 5337, Frame 0248 and by the Patent Division of the USPTO on August 5, 2014, at Reel 033472, Frame 0073;

WHEREAS, each Grantor has requested that Secured Party release its security interest in the Intellectual Property Collateral and reassign any and all rights in the same to such Grantor;

WHEREAS, each Grantor has satisfied and fulfilled all of its obligations to release the Secured Party's security interest in the Intellectual Property Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates the Security Agreement, and hereby discharges, cancels, terminates, and releases its security interest in all of each Grantor's right, title and interest in and to the following (collectively the "Intellectual Property Collateral"):

- (i) the Patents set forth on Schedule A hereto; and
- (ii) the Trademarks set forth on Schedule B hereto.

2. Secured Party hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Intellectual Property Collateral.




