RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE, dated as of December 16, 2015, is made by Madison Capital Funding LLC, in its capacity as Agent (in such capacity, together with its successor and permitted assigns, the "Agent"), pursuant to the Credit Agreement, dated as of October 1, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Guarantee and Collateral Agreement.

WITNESSETH

WHEREAS, Jameson, LLC, a Delaware limited liability company ("Grantor") is a party to the Credit Agreement;

WHEREAS, the Grantor agreed, pursuant to a Guaranty and Collateral Agreement of even date with the Credit Agreement, in favor of the Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement") to secure the Secured Obligations (defined in the Guarantee and Collateral Agreement);

WHEREAS pursuant to a certain Trademark Security Agreement (the "2010 Trademark Security Agreement") dated as of October 1, 2010, the Grantor granted to the Agent a Lien on and security interest in, all of the Grantor's right, title, and interest in, to and under the Trademark Collateral, (as defined in the 2010 Trademark Security Agreement);

WHEREAS pursuant to a certain Trademark Security Agreement (the "2013 Trademark Security Agreement") and together collectively, with the 2010 Trademark Security Agreement, the "Trademark Security Agreements") dated as of November 19, 2013, the Grantor granted to the Agent a Lien on and security interest in, all of the Grantor's right, title, and interest in, to and under the Trademark Collateral (as defined in the 2013 Trademark Security Agreement);

WHEREAS, the Grantor recorded the 2013 Trademark Security Agreement with the U.S. Patent and Trademark Office (the "USPTO") (i) on December 12, 2013 at Reel/Frame No. 5172/0539

WHEREAS, the Agent acknowledges the payment and performance of all the Secured Obligations, and thus desires to terminate and release the security interest in the Trademark Collateral granted pursuant to each of the 2013 Trademark Security Agreement and the 2010 Trademark Security Agreement.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Liens. The Agent hereby (i) terminates, without recourse, representation or warranty the Trademark Security Agreements; (ii) releases, without recourse, representation or warranty, express or implied, of any kind, its security interest in all of the Trademark Collateral; and (iii) retransfers and reassigns to the Grantor, as applicable, any right, title or interest of the Agent in, to or under the Trademark Collateral, including the issued trademarks and trademark applications set forth in Schedule I, attached hereto and incorporated herein by reference.


2. Authorization to Record. The Agent authorizes and requests that the USPTO and any applicable government officer record this Release.
