ASSIGNMENT

AGREEMENT made effective the 21st day of April, 2015, by and between

NANCY T.Y. GUH residing at
20 Confucius Plaza, Apt. 21M,
New York, New York 10002 ("ASSIGNOR"); and

VICKY LUK residing at
30 Douglas Court
Staten Island, NY 10304 ("ASSIGNEE");

WHEREAS, ASSIGNOR and ASSIGNEE have been co-owners in equal percentage, of the business and corporation known as E-WORLD TRAVEL & TOURS, INC. ("THE CORPORATION"), together with the goodwill and trade properties associated therewith, and more particularly, United States Trademark Application Serial No. 86313294 for the mark "E E-WORLD TRAVEL & TOURS INC" (hereinafter the "Trademark"); and

WHEREAS, ASSIGNOR is desirous of selling her entire right, title and interest in and to the Corporation and the Trademark, including the goodwill of the business associated therewith, as well as all common-law rights, to ASSIGNEE; and

WHEREAS, ASSIGNEE desirous of purchasing ASSIGNOR'S entire right, title and interest in and to the Corporation and the Trademark including the goodwill of the business associated therewith, as well as all common-law rights; and

WHEREAS, pursuant to a Stock Purchase Agreement entered into on April 21, 2015, ASSIGNOR and ASSIGNEE agreed that ASSIGNOR would sell to ASSIGNEE, ASSIGNOR'S entire right, title and interest in the Corporation in the Trademark, wherefore ASSIGNEE would become the sole owner of said Corporation and said Trademark; and

WHEREAS, it is the intention of the parties that the transfer of ASSIGNOR'S entire right, title and interest in the Corporation and the Trademark be formally confirmed in a writing:

NOW, THEREFORE, for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto covenant and agree as follows:

ASSIGNOR hereby conveys, transfers and assigns to ASSIGNEE all of her right, title, and interest in and to the Corporation and the Trademark, and all common-law rights together with the goodwill of the business symbolized thereby.

ASSIGNOR further assigns to ASSIGNEE all rights to sue for and receive all damages occurring from past infringing uses of the Trademark.

ASSIGNOR agrees that upon request by ASSIGNEE, ASSIGNOR shall execute all papers, make all rightful oaths, testify on behalf of ASSIGNEE and do all other lawful acts necessary to carry out the intent of this Assignment as well as provide such other material, information, or assistance as ASSIGNEE may consider necessary.
