TRADE-MARK ASSIGNMENT

AND WHEREAS the Assignor wishes to assign the Trade-marks to the Assignee, and the Assignee wishes to confirm its ownership of the whole right, title and worldwide interest in and to the Trade-marks;

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Assignor sells, assigns and transfers unto the Assignee, its successors, assigns or legal representatives, the whole right, title and worldwide interest to the Trade-marks, together with the goodwill of any and all business carried on in association with and symbolized by the trade-marks and in the Trade-marks, and together with the right to sue for and recover damages in the name of the Assignee for any and all past and future infringements of such Trade-marks the same to be held by the Assignee, its successors, assigns or legal representatives, as fully and effectively as they would have been held by the Assignor had this sale, assignment and transfer not been made;

AND the Assignor confirms that it has waived and does hereby irrevocably waive in favour of the Assignee now and in the future any and all rights in the Trade-marks which may have accrued to the Assignor, including but not limited to any moral rights for copyrights in the Trade-marks;

AND the Assignor hereby authorizes the issuance of any and all said registrations for the Trade-marks, not already issued, to the Assignee, its successors, assigns or legal representatives;


AND the Assignor, on behalf of itself, its successors, assigns and legal representatives, hereby covenants and agrees, without further consideration, to do all such lawful acts and things and to execute such further lawful assignments, documents, assurances, applications, oaths, declarations, powers of attorney and other instruments as reasonably may be required by the Assignee, its successors, assigns or legal representatives, to obtain any and all registrations, re-issues or extensions of registrations for the Trade-marks and to vest the same in the Assignee, its successors, assigns or legal representatives, and in furtherance of the Assignee's attempts to protect the Trade-marks and the goodwill therein;

AND, Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements in conflict herewith.

This Assignment shall be governed and construed in accordance with the internal laws of the Province of Ontario, without regard to conflicts of law principles; shall be binding upon the Assignor, its successors and assigns; and may not be modified orally, but instead only by an agreement or instrument in writing.

THIS ASSIGNMENT is effective as of December 10, 2015 ("Effective Date").
