RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Madison, on behalf of itself, the Lenders (as defined in the Security Agreement), and the Hedging Affiliates (as defined in the Security Agreement), hereby: (i) terminates the Security Agreement; and (ii) unconditionally and irrevocably releases, terminates and forever discharges and extinguishes any and all of its right, title and interest in and to any and all of its liens on and security interests in the Trademark Collateral (as defined in the Security Agreement) granted pursuant to the Security Agreement, including the trademarks listed on Schedule 1 attached hereto. Madison hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
