WHEREAS, pursuant to the terms of the Credit Agreement, the Agent and the Pledgors entered into that certain Amended and Restated Trademark Security Agreement, dated as of January 8, 2013 (as amended, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), by the Pledgors in favor of the Agent, recorded in the U.S. Patent and Trademark Office (“USPTO”) on January 11, 2013 at Reel 4941/Frame 0001 as supplemented by (i) that certain Supplement No. 1 to the Amended and Restated Trademark Security Agreement, dated as of October 16, 2013, by the Pledgors in favor of the Agent, recorded in the USPTO on January 21, 2014 at Reel 5197/Frame 0272, (ii) that certain Supplement No. 2 to the Amended and Restated Trademark Security Agreement, dated as of February 28, 2014, by the Pledgors in favor of the Agent, recorded in the USPTO on March 19, 2014 at Reel 5240/Frame 0335, (iii) that certain Supplement No. 3 to the Amended and Restated Trademark Security Agreement, dated as of December 17, 2014, by the Pledgors in favor of the Agent, and (iv) that certain Supplement No. 4 to the Amended and Restated Trademark Security Agreement, dated as of January 22, 2015, by the Pledgors in favor of the Agent;

WHEREAS, pursuant to the Credit Agreement and the Trademark Security Agreement, each Pledgor, as applicable, granted to the Agent (for the benefit of the applicable Secured Parties (as defined in the Credit Agreement)), a security interest in and to all personal property of such Pledgor, including, without limitation, the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Obligations (as defined in the Credit Agreement) have been paid in full, and the Borrowers and each other Pledgor have satisfied and fulfilled all of their obligations to release the Agent’s security interests in the Trademark Collateral; and

WHEREAS, the Pledgors have requested that the Agent (a) terminate and release its security interests in the Trademark Collateral and (b) provide a document suitable for recording in
