RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of this 17th day of December, 2015, by Madison Capital Funding LLC, a Delaware limited liability company, as Agent ("Madison"), in favor of Ribelin Sales, Inc., a Texas corporation ("Company").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Madison hereby terminates, releases and discharges the entirety of its liens on and security interests in the Trademark Collateral (including, without limitation, the Trademarks listed on Schedule 1 attached hereto and made a part hereof), which liens and security interests were established under and pursuant to that certain Trademark Security Agreement dated April 9, 2013, by Company in favor of Madison and recorded with the United States Patent and Trademark Office on April 9, 2013 at Reel/Frame 5001/0980 (the "Trademark Security Agreement") and any right, title or interest of Madison in such Trademark Collateral granted under the Trademark Security Agreement shall hereby terminate, cease and become void.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
