RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of December 18, 2015 (the “Effective Date”) by Fortress Credit Co LLC, in its capacity as collateral agent for itself and the other Secured Parties (as defined in the Security Agreement) (together with its successors, “Collateral Agent”) for the benefit of the Edelman Financial Services, LLC (the “Grantor”). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain (i) Pledge and Security Agreement dated as of September 20, 2012, among the grantors party thereto and Collateral Agent (the “Security Agreement”) and (ii) Trademark Security Agreement dated as of September 20, 2012 (the “Trademark Security Agreement”), among the Grantor and Collateral Agent, the Grantor pledged, assigned and granted to Collateral Agent a continuing security interest in all of its right, title and interest in and to the Collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith; and

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 24, 2012 at Reel 4866 and Frame 0306.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Collateral, including but not limited to the Collateral listed under Schedule I attached hereto, and including, without limitation, the goodwill exclusively symbolized thereby, all renewals of the foregoing, and all proceeds of the foregoing, including any claims against third parties for, or damages arising from, past, present or future infringement or dilution of the Collateral.

If and to the extent Collateral Agent has acquired any right, title or interest to any of the Collateral, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

Collateral Agent shall take all further actions, and provide to the Grantor and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.

This Release shall be governed by and construed in accordance with, the laws of the State of New York.
