TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment"), dated December 15th, 2015 (the "Effective Date"), is by and between Banco Santander, S.A., a Spanish corporation with a principal place of business at Santander Group City, Boadilla del Monte, Madrid 28660, Spain (the "Assignor"), and Santander Consumer USA, Inc., an Illinois corporation with a principal place of business at 8585 N. Stemmons Freeway, Suite 1100N, Dallas, Texas 75247, United States (the "Assignee").

WHEREAS, Assignor is the joint owner of U.S. Trademark Registration No. 4,084,055 for the mark **HELPINGLOANS.COM** registered on the Principal Register of the United States Patent and Trademark Office (the "Assigned Mark");

WHEREAS, the Assigned Mark is jointly owned by Assignor and Assignee; and

WHEREAS, Assignee now desires to acquire all of Assignor's right, title and interest throughout the world in and to the Assigned Mark together with the goodwill of Assignor's business symbolized by the Assigned Mark and Assignor desires to assign such right, title and interest to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment and Acceptance. Assignor does hereby sell, transfer, assign, convey and deliver to Assignee and its successors, assigns, or other legal representatives, all of Assignor's right, title and interest throughout the world in and to the Assigned Mark, together with the goodwill of the Assignor's business symbolized by the Assigned Mark, including without limitation all of the rights in damages for past, present and future infringements of the Assigned Mark. Assignee does hereby accept all of Assignor's right, title and interest throughout the world in and to the Assigned Mark, together with the goodwill of the Assignor's business symbolized by the Assigned Mark.

2. Recordation. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States to record ownership of the Assigned Mark as the property of Assignee.

3. Future Cooperation. Assignor further agrees to execute and deliver all reasonably requested assignments and other documents, and to take such other reasonable measures as Assignee shall reasonably request in order to confirm, perfect or evidence more clearly Assignee's rights in the Assigned Mark.


4. Counterparts. This Assignment may be executed simultaneously in one or more counterparts (including by facsimile or electronic .pdf submission), and by the different parties in separate counterparts, each of which when executed shall be deemed to be an original, but all of which shall constitute one and the same agreement.


