THIS TRADEMARK RELEASE is made as of December 17, 2015 by GCI CAPITAL MARKETS LLC, as Administrative Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and INTEGRAMED AMERICA, INC., a Delaware corporation ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of September 20, 2012 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on **Schedule I** hereto; and


