## TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of December 17, 2015 by GCI CAPITAL MARKETS LLC, as Administrative Agent ("**Agent**").

### WITNESSETH:

WHEREAS, Agent and INTEGRATED MANAGEMENT, LLC, a Delaware limited liability company ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of April 30, 2014 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on **Schedule I** hereto; and

  - (b) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
  - (c) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement, misappropriation, dilution, violation or impairment of any Trademark registration owned by Grantor including, without limitation, the Trademark registrations referred to in **Schedule 1** annexed hereto and the Trademark registrations issued with respect to the Trademark applications referred to in **Schedule 1** annexed hereto.
2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks.
