TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made and entered into as of December 1, 2015 by and between IRIS INTERNATIONAL, INC., a Delaware corporation, having an address of 9158 Eaton Avenue, Chatsworth, California 91311, (hereinafter referred to as "ASSIGNOR"), and BECKMAN COULTER, INC., a Delaware corporation, having a place of business 250 S. Kraemer Boulevard, Brea, California 92821 (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of all right, title, and interest in, under, and to the trademarks in Attachment 1 (hereinafter the "Trademarks"); and

WHEREAS, ASSIGNOR entered into an Asset Purchase and Secondment Agreement (the "APSA") with ASSIGNEE dated May 27, 2013, where ASSIGNOR'S Trademarks ("Trademarks") were recorded in said Agreement as an Excluded Asset; and

WHEREAS, ASSIGNOR and ASSIGNEE entered into a License Agreement dated May 27, 2013, where ASSIGNOR provided ASSIGNEE with a license to certain technology and patents owned by ASSIGNOR (including ASSIGNOR's trademarks) for the purpose of allowing ASSIGNEE to manufacture, distribute, use and sell such Licensed Products; and

WHEREAS, ASSIGNEE as the successor in interest to the portion of ASSIGNOR's business to which the trademarks pertain, is desirous of acquiring said Trademarks, along with the goodwill of the business pertaining thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said ASSIGNOR does hereby irrevocably sell, convey, assign, and transfer unto the said ASSIGNEE all right, title and interest in, under, and to all its Trademarks worldwide and the registrations therefor, together with the goodwill of the business connected with the use thereof and symbolized thereby, any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages. ASSIGNOR hereby agrees to execute any additional documents to accomplish this Assignment.


Notwithstanding any provision to the contrary set forth herein or in any document, instrument or agreement executed in connection herewith or therewith, no provision of this Assignment in any way waives, restricts, alters, diminishes, or limits the express provisions (including the warranties, covenants, agreements, conditions, representations and obligations and indemnifications, and the limitations related thereto, of the Parties) set forth in the ASPA and/or the License, this Assignment being intended solely to effect only the transfer of the Trademarks. In the event of a conflict between the terms of this Assignment and the terms of either the ASPA or the License, the terms of the ASPA shall prevail and govern.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile, portable document format or other electronic means shall be effective as delivery of a manually executed counterpart to this Assignment.
