WHEREAS, ASSIGNOR, and ASSIGNEE, acknowledge that contemporaneous to this Assignment and by separate agreement, TRANSPEC, INC., TRANSPEC INTERNATIONAL, INC., a Michigan corporation, RONALD LAMPARTER and SPECIALTY MANUFACTURING, INC., have entered in an Asset Purchase Agreement by which SPECIALTY MANUFACTURING, INC. agrees to acquire substantially all of the assets of TRANSPEC, INC. and TRANSPEC INTERNATIONAL, INC.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto the said ASSIGNEE, its successors and assigns, all of its rights title and interest without representation or warranty to said United States and foreign patents, patent applications, trademarks and trademark applications as identified in the attached Exhibit A, and to any continuation, division, renewal, substitute or reissue thereof, or any legal equivalent thereof, in the United States or a foreign country for the full term or terms for which the same may be granted, including all priority rights under the International

Convention; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks or any equivalent foreign body to issue Letters Patent and trademark, or any legal equivalent thereof, to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said United States patents and trademarks as identified in the attached Exhibit A and legal equivalents as may be known and accessible to ASSIGNOR and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said United States patents and trademarks as identified in the attached Exhibit A and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.



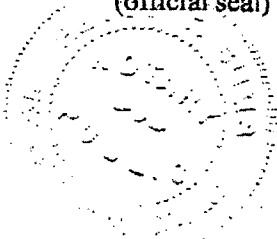
